

Steps to make payments

Go to the web page of school and click on the link Pay 24/7.

- Step 1: Enter your student information
- Step 2: Enter amount of Swiss Francs (CHF) for your payment
- Step 3: Select Country/currency for payment
 - Select payment Country/currency Due to international banking regulations some currencies are unable to be traded as part of this service. In instances where your currency does not appear as an option, please selectan alternative currency as the United States dollar.
 - Enter payer details and print document Containing account information for Western Union Business Solutions. Transfer your payment at your bank or via your online banking service, if applicable
- Step 4: Payment finalised Make payment at your bank using the instructions. Western Union Business Solutions will transfer your payment to your Educational Institution in Swiss Francs (CHF), on the same day we receive your payment.

Which fees can I pay using this service?

In instances where your country does appear as an option but the currency is unavailable, the system will default to the next best currency to use.
